Partner with industry educators to standardize best practices that meet the evolving needs of the community.

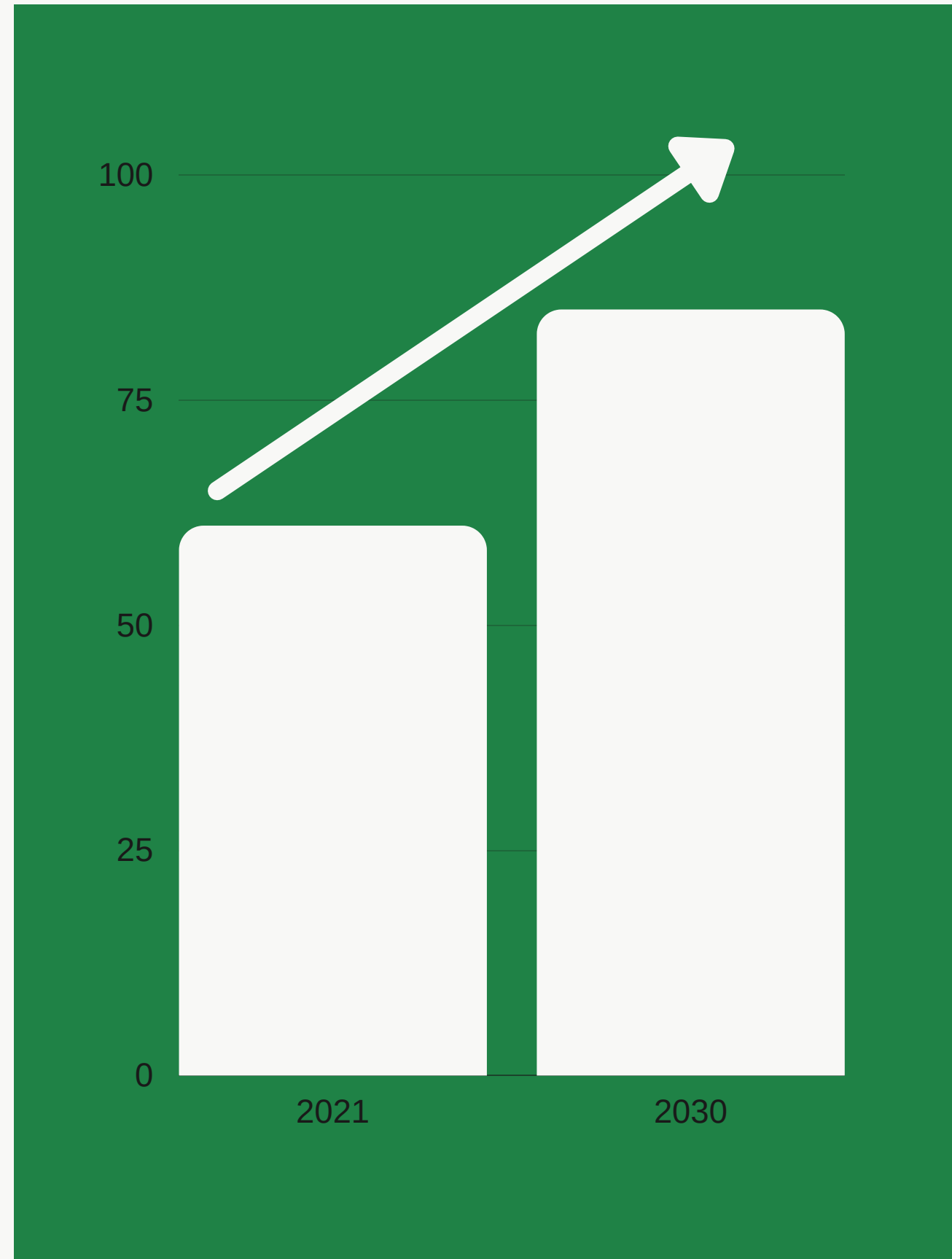
## ACCESSIBLE INTERFACE

## POTENTIAL USER BASE

A 2019 data scrape revealed **12,675 active dispensaries** this has since **doubled**.

**40%** of business owners spend time on **non-income** activities.

An average company **loses** up to **2.5%** of its **total revenue** onboarding.

**13% of medical schools** surveyed teach **endocannabinoid** science.

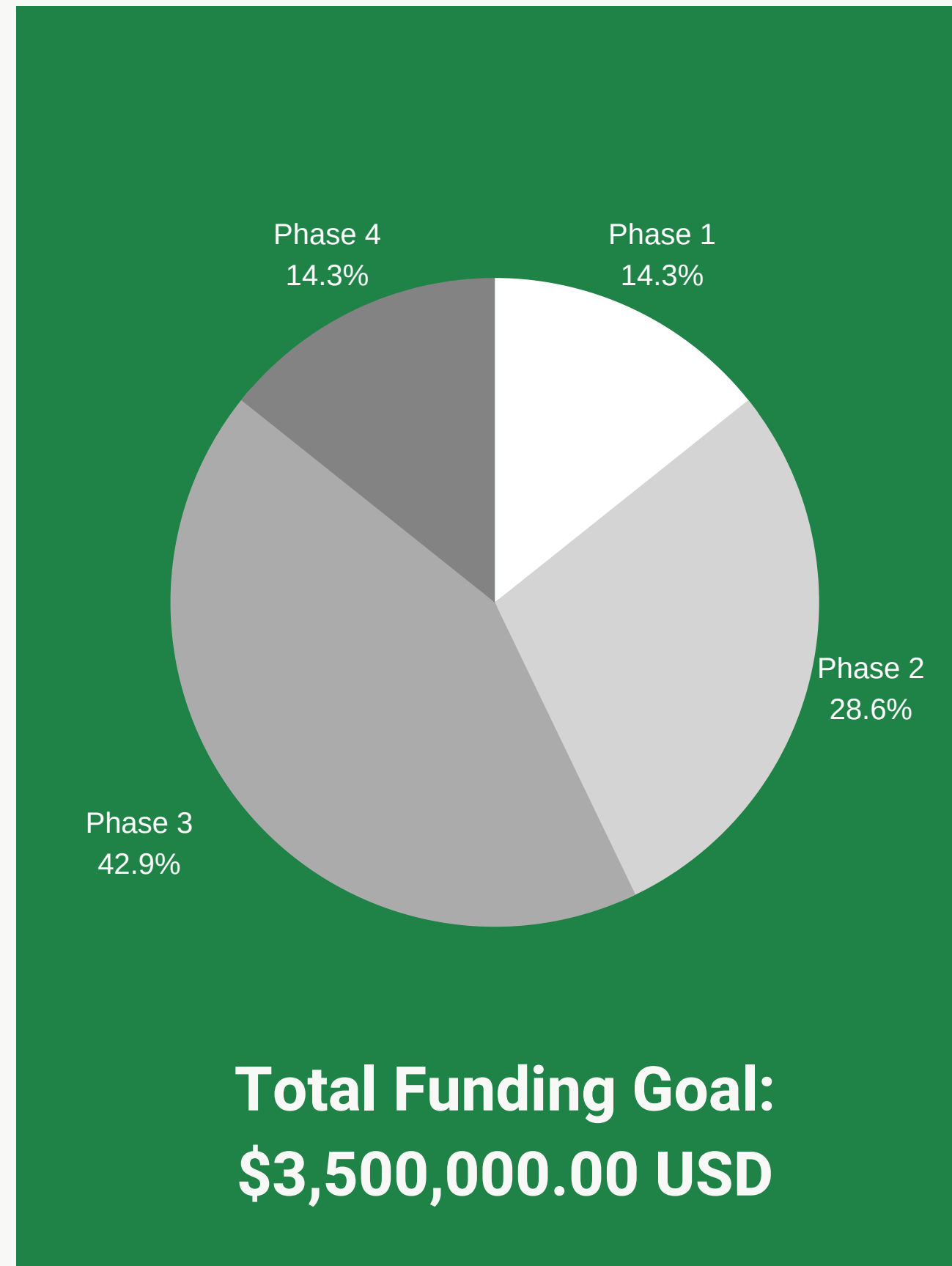
